



### South Section of the NJWEA Scholarship Awards

**Joseph W. Manganaro Scholarship Award:** This scholarship award of \$1,500 is intended for a graduating New Jersey High School Senior or full-time student enrolled in an Environmental or Engineering program in a New Jersey College or University. Criteria: The award is based on academic performance, merit, scholastic ability and demonstrated interest in Environmental Science or Engineering. Individuals must be a senior in a New Jersey High School or Technical School, actively seeking full-time enrollment in an Approved program at a New Jersey College or University. Individuals must be enrolled full-time in a New Jersey College or University in a program leading to a degree in Environmental Science or Engineering, or a closely related field with an emphasis in areas of environmental protection and/or water resources. Contact your Section's Award Committee member or Section President for an application and requirement information.

**Blake Maloney Scholarship Award:** This scholarship award of \$1,500 is for a person who is continuing their education in Technical Certifications. These certifications can include Plumber, Millwright, Electrician, Instrument Tech, etc. The student must be enrolled in a recognized certification program and has completed at least one semester towards the certification, the student must also be a resident of New Jersey and working in the wastewater industry.

**Robert Ingles Scholarship Award:** This Scholarship award of \$1,500 is for a person who has completed at least one semester at a County College in course work that would position them to receive an Associate's degree in Science.

**Memorial Scholarship:** This scholarship award of \$1,500 is to honor those who have passed on. This scholarship is for a person seeking a Master's Level degree Environmental Science or Engineering, or a closely related field with an emphasis in areas of environmental protection and/or water resources. Consideration will be given to individuals seeking to obtain a New Jersey Wastewater or Collection System Operators License whom are enrolled in a Wastewater Operators Certification Course.

**SOUTH SECTION OF THE NEW JERSEY WATER ENVIRONMENT ASSOCIATION SCHOLAR AWARD APPLICATION**

The South section of the New Jersey Water Environment Association, if adequate funds are available and have been approved by the membership, may present up to four (4) scholar awards to an individual whom meets the described criteria. The amount of scholar awards for 2019 is \$1500.

**CRITERIA FOR AWARD:**

1. The nominee must be sponsored by a New Jersey Water Environment Association member, with preference being given to nominees sponsored by a South Section Member.
2. The nominee must have maintained a cumulative grade point average of 3.0/B or greater for the three (3) reporting periods prior to making application for the award. Proof in the form of report cards or transcripts shall be attached to the application.
3. The student has taken a course(s) related to the environment or an approved course related to the study of Wastewater Treatment or Collection Systems.
4. The nominee must submit a letter of recommendation from a faculty member of the Science Department. 5. The nominee plans to continue his/her post-secondary education in an Associates, or Bachelor's Degree Program, in Engineering, Environmental Science or other wastewater related environmental studies, such as Biology or Chemistry, etc., or a certificate program in a vocational field, related to the wastewater industry (Ex. Electrical Maintenance, Electronics, Welding, Heavy Equipment Operation/Office, Systems Technology, etc.)
