- The South Sections Association checking account balance as of October 31, 2024 was \$54,905.09.
- The Section's Wells Fargo scholarship portfolio for October 31, 2024 had a closing value of \$25,279.94. This value includes (4) \$6,000 CDs maturing November 2024, March 2025, November 2026, and May 2027. The current market value is \$24,777.02 and the cash and sweep balance is \$1,002.92.

**Legislative Report:** Dennis W. Palmer

- **Bill A4124** Establishes minimum qualifications for persons employed on public works contracts. Any contractor submitting a bid for a contract which is paid for in whole or in part out of the funds of a public body in this State will certify that each employee completing work established in the contract meets at least one of the following qualifications (1) has earned a high school or GED diploma; (2) is currently enrolled in an apprenticeship program that is equivalent to the building and trade union that is specific to their craft; or (3) has completed four years of documented work as a tradesperson that can be verified by their tax filings.  
**11/14/2024** Reported out of Assm. Comm. With Amendments and referred to Assm. Labor Committee.
- **Bill A4965** Requires paint producers to implement or participate in paint stewardship program.  
**11/14/2024** Reported and Referred to Assm. Appropriations Committee.
- **S3849** Increases certain local public contract bid threshold. Raises the \$17,500 to \$22,000 – small improvement.
