- Bill LaPorte was called away on an unexpected business trip, he sends his regards and has donated his paid meal. While he was driving, he gave me the rundown of his report.
- This years' Vendors Day event was a success. The joint event was successful because of the many volunteers from the NJWEA and the South Jersey Water Professionals. Our success is also due to the strong support that we have from our Vendors.
- One hundred and twenty-five vendors attended this year and registered sixty-four tables. Vendors also sponsored an additional \$1,650; Core & Main sponsored our breakfast, and we had many wonderful, donated door prizes that kept our one hundred and seventy-four attendees in suspense.
- Next years' event will be on February 7th, 2025, the first Friday in February at the Scottish Rite Auditorium for the same cost as this year. We are waiting for confirmation from the Caterer.

Industrial: Chris Jepson, report submitted

• We are still putting together a complete industrial WWTP tour and South Section group meeting. I recently visited the Oatly WWTP in Millville, they make oat milk there. Nice and high tech – great WWTP with both activated sludge and DAF units – unusual to see both processes at any treatment plant – municipal or industrial . Worthy of our group's interest. If nothing else comes up – I make a motion to contact Oatly and set up a visit. Dates and times must be ironed out and approved by our President. Please contact me with any other ideas for an industrial meeting venue. Several ideas have been forwarded but none have come to fruition. Who has major industrial dischargers in their area? Legislative Report: Dennis W. Palmer

- The good news for the lame duck sessions is that it was not too bad. Not a mad rush of dozens or even hundreds of bills as in the past.
- We now have the 2024-2025 session in place and the committees have only met on January 25 and 29th and for February is a much busier calendar with 7 committee meeting dates. A joint session of both houses was held on February 27 to hear the Governor's budget message. However, several bills have been filed, with 5945 bills pre-filed with the start of the new session on January 9th. Some bills of interest to the Association are below, it has been a quiet time on environmental bills so far:
- *Bill S198* Prohibits investment by State of pension and annuity funds in, and requires divestment from, 200 largest publicly traded fossil fuel companies. I added this as it may impact the pension fund return on investment.
- 1/9/2024Introduced in the Senate, Referred to Senate State Government, Wagering, Tourism & Historic Preservation Committee
- 2/5/2024Transferred to Senate Environment and Energy Committee
- *Bill S2594* Appropriates \$28,670,924 in 2003 and 1992 bond act monies for loans for dam restoration and repair projects and inland waters projects.
- 2/8/2024Introduced in the Senate, Referred to Senate Environment and Energy Committee
- Bill SCR11 Amends Constitution to prohibit construction of new fossil fuel power plants.
- 1/9/2024Introduced in the Senate, Referred to Senate Environment and Energy Committee.
- *Bill A547* Requires public agency receiving State funds to post on website use of State funds for public work contracts with minority, women, and veteran owned businesses. This bill requires a public agency that is receiving State funds for the purpose of public work to post on its main website for public inspection an accounting of how much of those funds were used for public work contracts in which the public agency contracted with businesses to owned by minorities, women, and veterans.
- 1/9/2024Introduced, Referred to Assembly Labor Committee
- 2/5/2024Reported out of Assembly Committee, 2nd Reading
- The following bills have not seen committee action, but are being monitored:
 - **A328** Requires all elected or appointed local government officers to receive ethics training. This would apply to commissioners as well as elected officials.
 - o A1732 Prevents intoxicated employees from receiving workers' compensation.

- A1790 Establishes registry of out-of-state contractors who are awarded public works contracts in this State.
- A2043 Applies local public contract bid threshold amounts to local pay to play and prevailing wage laws. This is a good bill.
- A3111 Requires use of design-bid-build or design-build delivery system for certain local government construction projects.
